

**AMENDMENT TO H.R. 964**  
**OFFERED BY MR. RUSH**

Page 3, beginning on line 8, strike “that a user of the computer can not close” and insert “or a series of advertisements that a user of the computer can not close or terminate”.

Page 7, line 3, strike “execution of” and insert “downloading or installing”.

Page 7, line 4, strike “functions of the”.

Page 8, line 13, strike “WEB PAGES VISITED” and insert “INTERNET ACTIVITY”.

Page 8, line 16, strike “Web pages accessed” and insert “user’s internet activity”.

Page 8, line 22, strike “WEB PAGES VISITED” and insert “INTERNET ACTIVITY”.

Page 9, beginning on line 4, strike “Web pages that are accessed using the computer” and insert “the user’s internet activity”.

Page 10, beginning on line 1, strike “such notice” and insert “a statement required under subparagraph (B)”.

Page 17, beginning on line 21, strike “including remedies available to the Commission under the Federal Trade Commission Act” and insert “and other remedies available to the Commission in an enforcement action against unfair or deceptive acts and practices”.

Page 19, line 13, strike “No provider” and insert:

Page 19, after line 21, insert the following:

2           (2) CONSTRUCTION.—Nothing in this sub-  
3           section shall be construed to limit the liability of a  
4           provider of computer software or of an interactive  
5           computer service for any anti-competitive act other-  
6           wise prohibited by law.

Page 21, after line 9, insert the following:

7           (4) EFFECTIVE DATE.—The preemption pro-  
8           vided for under this subsection shall take effect, with  
9           respect to specific provisions of this Act, on the ef-  
10          fective date for such provisions.

Page 21, strike line 16 through page 22, line 9.

Page 22, line 10, strike “**SEC. 8**” and insert “**SEC.  
7**”.

Page 22, beginning on line 12, strike “the date of enactment of this Act” and insert “the date on which final regulations are issued under section 10”.

Page 23, line 18, strike “**SEC. 9**” and insert “**SEC. 8**”.

Page 23, after line 17, insert the following:

1       (d) PAPERWORK REDUCTION REQUIREMENTS.—The  
2 requirements of subchapter I of chapter 35 of title 44,  
3 United States Code, shall not apply to the report required  
4 under this section.

Page 23, line 22, strike “the date of enactment of this Act” and insert “the date on which final regulations are issued under section 10”.

Page 24, line 9, insert after the period the following:  
“The requirements of subchapter I of chapter 35 of title 44, United States Code, shall not apply to the report required under this section.”

Page 24, line 10, strike “**SEC. 10**” and insert “**SEC. 9**”.

Page 24, line 13, strike “6-month” and insert “9-month”.

Page 24, line 22, strike “**SEC. 11**” and insert “**SEC. 10**”.

Page 26, line 22, strike “DECEPTIVE” and insert “UNFAIR OR DECEPTIVE”.

Page 26, line 23, strike “deceptive” and insert “un-fair or deceptive”.

Page 30, line 7, strike “are necessary to”.

Page 31, line 6, strike “**SEC. 12**” and insert “**SEC. 11**”.
